A warning was sent out on social media about an attempted hijacking close to Job Shimankana Tabane provincial

Rustenburg – A warning was circulated on social media urging residents to avoid using the road behind Job Shimankana Tabane (JST) provincial hospital and the road at the corner of Bosch and Heystek Street.

The warning further stated that criminals are placing rocks across the road causing motorists to stop, giving the hijackers an opportunity to strike. A municipal vehicle allegedly almost fell victim to hijackers at this spot.

What makes it worse is that it's a very busy route, with several schools, shopping centers, other hospitals and businesses within a close proximity.

Police spokesperson sergeant Ofentse Mokgadi stated that although there were no hijacking incidents reported for this area, police are aware of various motor vehicle thefts around the hospital.

The crime in the area got JST management to sharpen their security and various additional measures are being put in place to make sure that their staff

"We received numerous complaints about cars being stolen outside the facility so additional security is being outsourced. These guards and officials are placed in strategic areas around the hospital," said JST acting chief executive officer Gloria Thlapi in an interview with Platinum Weekly.

The areas where the additional security has been placed include the casualty entrance, the maternity ward and the mental health department. There are also plans in place to strengthen security measures in the parking area that includes a motorised gate, proper access control, guard houses where security can monitor all the cars coming in an out as well as CCTV cameras at various entrances.

Tlhapi received a tip from police about people barricading the roads with stones around the hospital. She urges people using this road to be vigilant and, as far as possible, to avoid traveling alone at night.

Tlhapi added: "We want to make sure that those visiting the hospital feel safe to do so. We would like to assure the community that we have their safety and interests at heart, and we are working on making it safer." She also said that people should ask the security at the hospital's gate to accompany them to their vehicles at night.

The hospital however can only do so much to up security on their premises, so they reiterated the fact that the community need to be careful and aware when using the roads around the hospital and that it is still the responsibility of the police to keep the community safe.







## **KZN** flooding: "biggest mass rescue operation we have faced in recent history"


KZN - On 11 and 12 April, certain parts of KwaZulu- The National Sea Rescue Institute (NSRI) commended Natal received between 200 and 400 mm of rainfall in the massive response from our NSRI stations in Port a 24-hour period.

#### **Background**

Rustenburg - Platinum Weekly was made aware of a man pretending to be a lodge owner in our area, so we set out to investigate. We ended up going down a rabbit hole of scams. The audacity of this serial scammer is mind boggling. We are placing only one or two of his scams (per week) in our newspapers. We already interviewed several of his victims. This serial scammer is also extremely dangerous and armed. He was

recorded online. taking out his gun and threatening to shoot a man who confronted him about his scams.

It almost plays out like a movie... except it's not. It's real life and it's real people who lost real money. It is a pity, however, that only some of his victims have opened criminal cases against him. In some of the cases his scams appear to be nothing more than a power play... a need to impress the ladies..

# SERIAL SCAMMER

More and more victims are coming forward and Platinum Weekly aims to expose all of his scams in the weeks ahead. We hope to warn people about his modus operandi, so that they don't get caught up in his web of lies. Hopefully he will be brought to book soon so that his identity can be revealed.

To protect his victims, we will keep them anonymous.

#### **Far from home**

Victim 7 shared her story with Platinum Weekly. She saw a vacancy which was posted on Facebook for a receptionist at a game farm near Rustenburg. She applied for the position and received a call from Mr. Scammer shortly after. She was interviewed online and after about a week of corresponding with Mr. Scammer, she was informed that she got the job and that she starts working on 1 February. Because this new job opportunity was about 400km told her that there are bugs in her bed and that she had to share a bed with him!

This kite was not going to fly so she approached one of the lodge's staff members and asked for another bed. The employee apparently looked a bit taken aback and she pulled the covers of the bed and said: "The bed is clean, we don't have bugs at this place, look for yourself." The victim told her that the 'boss' said that there are bugs in the bed. The employee apparently asked her which boss she was referring to. When Victim 7 pointed

to Mr. Scammer, the employee indicated that Mr Scammer was not her boss.

At this stage Victim 7 knew that something was wrong but was stuck in a strange town with a strange man and he did not leave her side. He was always with her and listening in on the conversations. when she phoned her mother. Apparently, the staff member at the lodge realised that something was wrong and she informed the foreman at the lodge who constantly checked in with Victim 7 to make sure that she was okay.

a 'business meeting'. Victim 7 told the Platinum Weekly that they were walking around in a mall for hours before finally sitting down at a restaurant, waiting to meet a business partner. A very suspicious looking man came to meet Mr. Scammer.

Victim 7 could apparently not hear what they were saying but they kept looking over at her and she got a strange feeling that she was in danger. A while later, another suspicious looking man the victims.

met them and started talking in private with Mr Scammer (one side). She got the same looks as with the first visitor and she got the feeling that they were negotiating about something - maybe someone. She reached out to a friend in the area and asked the friend to come and fetch her at the mall. At that point a third dodgy guy came over and started talking about a party where there would be drugs and girls. Victim 7 told us that her phone's battery started getting low and that she asked Mr. Scammer if she could go and charge her phone to which he made an extremely vulgar remark. She asked Mr Scammer to go to his car with her so that she could fetch her bags. "I feared for my life, but got out of there as quickly as possible," she said. She waited in another restaurant for a friend, who came to fetch her.

During the short period of time she spent with Mr. Scammer, he constantly played on her emotions and he manipulated her. He apparently even pretended to be sick, looking for sympathy. Victim said that Mr Scammer had a gun on him the whole time. The only money she lost was paying for the accommodation but emotionally she was left traumatised by what happened.

He operates all over the show. If some of these stories sound familiar to you, please let us know about it. Even if you were scammed a year or two ago, you can still report it to SAPS. We urge victims to go to their nearest police station to open a case. This dangerous man should be brought to book.

### PROPERTY POWER STRUGGLE CONTINUES

**Dwaalboom** – The plot thickens in and out of court. involving four properties totalling 5,500 hectares outside Dwaalboom. In the latest judgement between four private companies (applicants) and the respondent Bakgatla-Ba-Kgafela Communal Property Association (BBKCPA), the judge ruled in favour of the applicants, 'Interdicting and restraining the Respondent and any other person acting under the authority of the Respondent from executing any allotment and/or lease agreements and disposing of and dealing with the properties.' In an interview with a local community member, who wishes to stay anonymous: "It's a power and property struggle involving the Bakgatla-Ba-Kgafela. A leadership shift in 2020 involved the provincial government and the High Court. Ever since then the power struggle has not ended and both sides have their own supporters. I would not be surprised if the torching of Kgosi Linchwe's property, on 23 October 2021, had something to do

> The power struggle is one thing. but the farmers on the property, who have invested thousands of hours and a lot of money into the farmlands in this dispute, are stuck in the middle.

> A letter to the editor sent by Farmer X, reads: "This is not my fight, but it's my money and hours spent to rehabilitate a piece of farmland for which I have a valid contract supplied by the BBKCPA. We have won two court cases thus far. All I want to do is farm."

His challenge started when a

community member, with no contract with the BBKCPA, started to plant sunflowers on the property in December 2021. The good rains at the beginning of the year soon transformed the fields into a sunflower haven and it is almost ready to harvest.

The community member is part of the businesses who won the latest court interdict.

The Limpopo High Court on 18 January 2022 ruled in favour of BBKCPA to 'immediately restore the property to BBKCPA for the peaceful and undisturbed possession, use and enjoy of the crops and farming purposes' of the said farms. The ruling also stated that members not affiliated by BBKCPA should immediately cease any and all farming activities.

In the meantime, the Limpopo High Court on 13 April 2022, ruled in favour of the private companies. The court stated that the BBKCPA does not have the authority to manage the properties.



### Air ambulance

Rustenburg – Every minute counts when transporting a seriously injured patient. Since helicopters can land at most hospitals, transporting patients by helicopter is very convenient and ensures the shortest possible travel time for seriously injured patients.

A woman was critically injured during an accident on the N4 on Thursday 7 April, when the taxi she was traveling in overturned. ER24 paramedics responded to the scene. The women's injuries included a humerus fracture, intracranial haemorrhage, and a diaphragmatic rapture. She was initially transported to Medicare whereafter she was referred to Job Shimankana

Tabane Provincial Hospital.

ER24 once again came to her aid after she had to be transferred to Ahmed Kathrada Private Hospital in Johannesburg. Due to the severity of her injuries, she had to be transported via helicopter. The team collected her from JST and took her to Bergsig Academy's sports grounds where the Rocket Air Ambulance was waiting



In another incident, ER24 paramedics saw to the safe transfer of a four-year-old girl who sustained serious injuries to her left femur in an accident on 18 April. It was decided that she should be transferred to Lenmed Randfontein Private Hospital. In the meantime, she was transferred to Ahmed Kathrada Private Hospital in Lenasia for further treatment The Rocket Air Ambulance was waiting for her on Laerskool Proteapark's sports grounds on 19 April, where the ER24 paramedics loaded her safely into the helicopter.

Her father was also on scene, making sure that his baby girl was on her way to receive the much-needed care. Once the helicopter was in the air, he followed in a car to meet them at the hospital.

### Four-year-old injured in accident

Rustenburg - Trauma Rescue paramedics responded to a horrific accident at the R24 and R104 crossing at Rudan Garage on Monday 18 April. When emergency services responded to the scene, they found five

people who were injured in an accident involving two vehicles. Trauma Rescue transported three of the five injured to hospital. Among these three was a fouryear-old girl who was a passenger in one of the vehicles. She sustained serious injuries to her left femur.




